SUMMARY

Chemicals in Singapore industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value 2017-21, and forecast to 2026). The chemicals market consists of speciality chemicals, commodity chemicals, agricultural chemicals, and other chemicals (which include products such as pharmaceutical chemicals).

The Singaporean chemicals market had total revenues of \$29.7 billion in 2021, representing a compound annual growth rate (CAGR) of -0.3% between 2016 and 2021.

The commodity chemicals segment accounted for the largest proportion of the market in 2021, with total revenues of \$14.0 billion, equivalent to 47% of the market's overall value.

The production of chemicals is the second largest manufacturing segment in Singapore, after electronics. Singapore has strong upstream and downstream

links in the market and most chemical companies are conveniently located on a manmade island called Jurong Island.
