The commodity chemicals segment accounted for the market's largest proportion in 2023, with total revenues of \$26.1 billion, equivalent to 59.4% of the market's overall value.

The chemicals market in Singapore is impacted by macroeconomic factors such as GDP growth, inflation rates, energy costs, technological advancement, and industrial production. For instance, according to GlobalData, the real GDP



annual growth stood at 1.2% in 2023.
