SUMMARY

Construction in Singapore industry profile provides top-line qualitative and quantitative summary information including: market size (value 2017-21, and forecast to 2026). KEY HIGHLIGHTS

The construction market is defined as the value of work put in place annually for both, residential and non-residential construction.

The Singaporean Construction industry had total revenues of \$19.3bn in 2021, representing a compound annual growth rate (CAGR) of -5.3% between 2016 and 2021.

The Non-Residential Construction segment was the industry's most lucrative in 2021, with total revenues of \$14.6bn, equivalent to 75.3% of the industry's overall value.

Decline in 2020 can be attributed to the COVID-19 pandemic which greatly impacted the Singaporean construction market as supply chain disruptions delayed construction projects and inhibited growth in the market.
