Within the skincare industry, China is the leading country among the top 5 emerging nations, with market revenues of \$48,018.5 billion in 2023. This was followed by Brazil and Mexico with a value of \$3,553.4 and \$3,134.4 billion, respectively.

China is expected to lead the skincare industry in the top five emerging nations, with a value of \$55,287.5 billion in 2028, followed by Brazil and Mexico with expected values of \$4,542.4 and \$4,164.4 billion, respectively.
