Soft Drinks in China

### SUMMARY

Soft Drinks in China industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2013-17, and forecast to 2022). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

### KEY HIGHLIGHTS

The soft drinks market consists of retail sale carbonates, squash/syrups, nectars, energy drinks, juice, packaged water, sports drinks, iced/RTD tea drinks, flavored water, still drinks, enhanced water, fruit powders, bulk/HOD water, and iced/RTD coffee drinks. However, the total market volume for the soft drinks market excludes powder concentrates, which are included in the market value. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions used in the creation of this report have been calculated using constant annual average 2017 exchange rates.

The Chinese soft drinks market had total revenues of \$122.8bn in 2017, representing a compound annual growth rate (CAGR) of 4.8% between 2013 and 2017.

Market consumption volume increased with a CAGR of 3.96% between 2013 and 2017, to reach a total of 142.4 billion liters in 2017.

A large population and changing consumer food habits mostly supported market

growth during the review period.
