The soft drinks industry within the NAFTA countries had a total market value of \$2,44,666.7 million in 2017.The Mexico was the fastest growing country, with a CAGR of 6.2% over the 2013-17 period.

Within the soft drinks industry, the US is the leading country among the NAFTA bloc, with market revenues of \$2,02,109.6 million in 2017. This was followed by Mexico and Canada, with a value of \$29,949.0 and \$12,608.0 million, respectively.



The US is expected to lead the soft drinks industry in the NAFTA bloc, with a value of \$2,51,121.2 million in 2022, followed by Mexico and Canada with expected values of \$40,438.7 and \$13,252.9 million, respectively.
