SUMMARY

Software in North America industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2016-20, and forecast to 2025). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The software market is defined as revenues generated from both sales of, and subscriptions to, various software packages and offerings. The market includes both signed deals that remain under contract, and the annual revenues associated with new contracts signed, within a particular calendar year. This excludes sales opportunities for third-party services providers.

The North American software market had total revenues of \$213.8bn in 2020, representing a compound annual growth rate (CAGR) of 2.3% between 2016 and 2020.

The business process applications segment was the market's most lucrative in 2020, with total revenues of \$73.9bn, equivalent to 34.6% of the market's overall value.

In recent years, growth across the region has been driven primarily by increased mobile and cloud computing usage among businesses and the population.
