SUMMARY

Software in North America industry profile provides top%li%line qualitative and quantitative summary information including: market size (value 2015%li%19, and forecast to 2024). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The software market is defined as revenues generated from both sales of, and subscriptions to, various software packages and offerings. The market includes both signed deals that remain under contract, and the annual revenues associated with new contracts signed, within a particular calendar year. This excludes sales opportunities for third%li%party services providers.

The North American software market had total revenues of \$219.9bn in 2019, representing a compound annual growth rate (CAGR) of 9% between 2015 and 2019.

The business process applications segment was the market's most lucrative in 2019, with total revenues of \$81.1bn, equivalent to 36.9% of the market's overall value.

The region has experienced strong growth rates in terms of its software market. The growth over the past five years has been driven primarily by increased



mobile and cloud computing usage among businesses.
