### SUMMARY

The NAFTA Software industry profile provides top-line qualitative and quantitative summary information including: market size (value 2016-20, and forecast to 2025). ### KEY HIGHLIGHTS

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The software industry within the NAFTA countries had a total market value of \$213.8 million in 2020. The Canada was the fastest growing country, with a CAGR of 2.7% over the 2016-20 period.

Within the software industry, the US is the leading country among the NAFTA bloc, with market revenues of \$194.9 million in 2020. This was followed by Canada and Mexico, with a value of \$13.4 and \$5.4 million, respectively.

The US is expected to lead the software industry in the NAFTA bloc, with a value of \$271.4 million in 2025, followed by Canada and Mexico with expected values of \$19.2 and \$7.7 million, respectively.
