SUMMARY

The construction market is defined as the value of work put in place annually for both, residential and non-residential construction.

The South African Construction industry had total revenues of \$26.1bn in 2021, representing a compound annual growth rate (CAGR) of -5.8% between 2016 and 2021.

The Non-Residential Construction segment was the industry's most lucrative in 2021, with total revenues of \$17.9bn, equivalent to 68.8% of the industry's overall value.

Decline in 2020 can be attributed to the COVID-19 pandemic which greatly impacted the South African construction market as supply chain disruptions delayed construction projects and inhibited growth in the market.
