SUMMARY

The Non-Residential Construction segment was the industry's most lucrative in 2021, with total revenues of \$140.5bn, equivalent to 61.5% of the industry's overall value.

Decline in 2020 of 0.5%. can be attributed to the COVID-19 pandemic which greatly impacted the South Korean construction market as supply chain disruptions delayed construction projects and inhibited growth in the market.
