SUMMARY

Spirits in Scandinavia industry profile provides top-line qualitative and quantitative summary information including: market size (value 2016-20, and forecast to 2025). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The spirits market consists of the sale of brandy, gin and genever, liqueurs, rum, specialty spirits, tequila and mezcal, vodka and whiskey. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions used in the creation of this report have been calculated using constant annual average 2020 exchange rates.

The Scandinavian spirits market had total revenues of \$6.2bn in 2020, representing a compound annual rate of change (CARC) of -2.9% between 2016 and 2020.

Market consumption volume increased with a compound annual growth rate (CAGR) of 0.6% between 2016-2020, to reach a total of 151.8 million litres in 2020.



The performance of the market is forecast to accelerate, with an anticipated CAGR of 6% for the five-year period 2020 - 2025, which is expected to drive the market to a value of \$8.2bn by the end of 2025.
