Summary

Spirits in Scandinavia industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2015-19, and forecast to 2024). Key Highlights

The spirits market consists of the sale of brandy, gin & genever, liqueurs, rum, specialty spirits, tequila & mezcal, vodka and whiskey. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions used in the creation of this report have been calculated using constant annual average 2019 exchange rates.

The Scandinavian spirits market had total revenues of \$6,826.4m in 2019, representing a compound annual growth rate (CAGR) of 0.1% between 2015 and 2019.

Market consumption volume increased with a CAGR of 0.1% between 2015 and 2019, to reach a total of 137.6 million liters in 2019.

Positive economic conditions and increasing purchasing power in the region are the key factors supporting the growth of the spirits market.
