The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The spirits industry within the NAFTA countries had a total market value of \$144,667.2 million in 2022. The US was the fastest growing country, with a CAGR of 5.9% over the 2018-22 period.

Within the spirits industry, the US is the leading country among the NAFTA bloc, with market revenues of \$122,566.0 million in 2022. This was followed by Canada and Mexico, with a value of \$15,277.9 and \$6,823.3 million, respectively.

The US is expected to lead the spirits industry in the NAFTA bloc, with a value of \$171,493.1 million in 2027, followed by Canada and Mexico with expected values of \$21,977.9 and \$11,826.0 million, respectively.
