SUMMARY

The Scandinavian sports equipment market had total revenues of \$5.3bn in 2018, representing a compound annual growth rate (CAGR) of 3.1% between 2014 and 2018.

Clothing, footwear and accessories specialists account for the largest proportion of sales in the Scandinavian sports equipment market in 2018, sales through this channel generated \$787.1m, equivalent to 14.9% of the market's overall value.

The growth of online pure play and multi-channel distribution as a method of for consumption of sports equipment demonstrates the growing importance of e-



commerce in the market.
