SUMMARY

The South African sports equipment market had total revenues of \$1.4bn in 2018, representing a compound annual growth rate (CAGR) of 5.3% between 2014 and 2018.

Clothing, footwear and accessories specialists account for the largest proportion of sales in the South African sports equipment market in 2018, sales through this channel generated \$391.0m, equivalent to 27.7% of the market's overall value.

Popular sports include football, rugby and cricket with large dedicated fan bases. Firms can gain significant revenue through equipment and merchandise from

these sports.
