#### **KEY HIGHLIGHTS**

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The sports equipment industry within the NAFTA countries had a total market value of \$48,555.1 million in 2018. The Mexico was the fastest growing country, with a CAGR of 6.5% over the 2014-18 period.

Within the sports equipment industry, the US is the leading country among the NAFTA bloc, with market revenues of \$43,919.6 million in 2018. This was followed by Canada and Mexico, with a value of \$4,202.5 and \$433.1 million, respectively.



The US is expected to lead the sports equipment industry in the NAFTA bloc, with a value of \$47,924.4 million in 2023, followed by Canada and Mexico with expected values of \$4,715.2 and \$582.5 million, respectively.
