Standard Pacific built homes in 25 markets through 15 operating divisions. The company owned 35,430 home sites (including joint ventures) and had 192 active selling communities. In FY2014, the company delivered over 81.0% from single-family detached homes and the rest from single family attached homes, generally townhomes and condominiums. Standard Pacific is headquartered in Irvine, California, the US.
