Summary

The market is segmented into Life Insurance and Pension/Annuity.

The Swedish life insurance market had total gross written premiums of \$44.1 billion in 2022, representing a compound annual growth rate (CAGR) of 14.1% between 2017 and 2022.

The pension/annuity segment accounted for the market's largest proportion in 2022, with total gross written premiums of \$22.9 billion, equivalent to 51.8% of the market's overall value.

Life insurance coverage in the Swedish population is relatively high. According to in-house research, in 2022, life insurance penetration (ratio of premiums to GDP) in Sweden was 7.5%.
