The bank credit segment accounted for the industry group's largest proportion in 2022, with total assets of \$1,934.7 million, equivalent to 50.5% of the industry group's overall value.

According to the OECD, the long-term interest rates of Swiss banks had increased significantly during the historic period, from -0.1% per annum in December 2017 to 1.6% per annum in December 2022.
