Key Highlights

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The syrups & spreads industry within the NAFTA countries had a total market value of \$10,528.8 million in 2022. The US was the fastest growing country, with a CAGR of 7.5% over the 2018-22 period.

Within the syrups & spreads industry, the US is the leading country among the NAFTA bloc, with market revenues of \$8,282.0 million in 2022. This was followed by Mexico and Canada, with a value of \$1,453.9 and \$792.9 million, respectively.

The US is expected to lead the syrups & spreads industry in the NAFTA bloc, with a value of \$10,546.7 million in 2027, followed by Mexico and Canada with expected values of \$1,915.2 and \$927.0 million, respectively.
