SUMMARY

The US syrups & spreads market had total revenues of \$8,674.6m in 2018, representing a compound annual growth rate (CAGR) of 8.3% between 2014 and 2018.

Market consumption volume increased with a CAGR of 6.7% between 2014 and 2018, to reach a total of 1,100.2 million kilograms in 2018.

Syrups & spreads market in the US is matured and saturated which allows less scope for growth acceleration.
