These countries contributed \$284,003.7 million to the global telecommunication services industry in 2016, with a compound annual growth rate (CAGR) of 0% between 2007 and 2011. The top 5 emerging countries are expected to reach a value of \$332,234.9 million in 2021, with a CAGR of 3.2% over the 2016-21 period.

Within the telecommunication services industry, China is the leading country among the top 5 emerging nations, with market revenues of \$195,882.0 million in 2016. This was followed by India and Brazil with a value of \$36,922.8 and \$26,287.6 million, respectively.

China is expected to lead the telecommunication services industry in the top five



emerging nations, with a value of \$236,436.4 million in 2021, followed by India and Mexico with expected values of \$43,667.1 and \$23,228.1 million, respectively.
