SUMMARY

Textile Mills in the United States industry profile provides top-line qualitative and quantitative summary information including: market size (value 2016-20, and forecast to 2025). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The textile mills market includes yarns and fabrics. The value of each segment is for consumption, defined as domestic production plus imports minus exports, all valued at manufacturer prices.

The US textile mills market had total revenues of \$73.4bn in 2020, representing a compound annual rate of change (CARC) of -1.5% between 2016 and 2020.

The fabric segment was the market's most lucrative in 2020, with total revenues of \$66.5bn, equivalent to 90.7% of the market's overall value.

The future of the US textile mills market will largely be dependent on economic policies and global trade agreements under Joe Biden's upcoming presidency in 2021.
