### Summary

Production volumes declined with a negative CAGR of 3% between 2017 and 2022, reaching a total of 21,145.2 thousand tonnes in 2022.

The growth in the Thai metal & mining market is influenced by many factors such as increasing industrialization, economic growth, technological advancement, and investment in government support and incentives in metals and mining. For instance, according to in-house research, the real GDP growth

in Thailand stood at 2.6% in 2022.
