These countries contributed \$55,390.2 billion to the global banks industry in 2021, with a compound annual growth rate (CAGR) of 8.3% between 2007 and 2011. The top 5 emerging countries are expected to reach a value of \$78,774.5 billion in 2026, with a CAGR of 7.3% over the 2021-26 period.

Within the banks industry, China is the leading country among the top 5 emerging nations, with market revenues of \$50,415.7 billion in 2021. This was followed by India and Brazil with a value of \$2,415.7 and \$1,654.2 billion, respectively.

China is expected to lead the banks industry in the top five emerging nations, with a value of \$71,532.9 billion in 2026, followed by India and Brazil with expected values of \$3,603.3 and \$2,416.3 billion, respectively.
