These countries contributed \$58,406.4 billion to the global banks industry in 2022, with a compound annual growth rate (CAGR) of 8.9% between 2007 and 2011. The top 5 emerging countries are expected to reach a value of \$88,385.0 billion in 2027, with a CAGR of 8.6% over the 2022-27 period.

Within the banks industry, China is the leading country among the top 5 emerging nations, with market revenues of \$52,974.9 billion in 2022. This was followed by India and Brazil with a value of \$2,559.1 and \$1,921.4 billion, respectively.

China is expected to lead the banks industry in the top five emerging nations, with a value of \$80,405.3 billion in 2027, followed by India and Brazil with expected values of \$3,930.3 and \$2,751.8 billion, respectively.
