Within the healthcare providers industry, China is the leading country among the top 5 emerging nations, with market revenues of \$1,225.7 billion in 2022. This was followed by Brazil and India with a value of \$200.6 and \$95.3 billion, respectively.

China is expected to lead the healthcare providers industry in the top five emerging nations, with a value of \$1,616.5 billion in 2027, followed by Brazil and India with expected values of \$286.4 and \$117.5 billion, respectively.
