### SUMMARY

These countries contributed \$192.9 billion to the global it services industry in 2021, with a compound annual growth rate (CAGR) of 9.9% between 2007 and 2011. The top 5 emerging countries are expected to reach a value of \$294.1 billion in 2026, with a CAGR of 8.8% over the 2021-26 period.

Within the it services industry, China is the leading country among the top 5 emerging nations, with market revenues of \$114.6 billion in 2021. This was followed by India and South Africa with a value of \$30.1 and \$18.9 billion, respectively.

China is expected to lead the it services industry in the top five emerging nations, with a value of \$174.0 billion in 2026, followed by India and Brazil with expected values of \$45.4 and \$28.5 billion, respectively.
