SUMMARY

These countries contributed \$88.2 billion to the global software industry in 2021, with a compound annual growth rate (CAGR) of 6% between 2007 and 2011. The top 5 emerging countries are expected to reach a value of \$129.1 billion in 2026, with a CAGR of 7.9% over the 2021-26 period.

Within the software industry, China is the leading country among the top 5 emerging nations, with market revenues of \$54.8 billion in 2021. This was followed by India and Brazil with a value of \$13.4 and \$7.9 billion, respectively.

China is expected to lead the software industry in the top five emerging nations, with a value of \$79.7 billion in 2026, followed by India and Brazil with expected values of \$19.4 and \$12.0 billion, respectively.
