Within the transportation services industry, China is the leading country among the top 5 emerging nations, with market revenues of \$576,234.1 million in 2021. This was followed by India and Brazil with a value of \$136,727.2 and \$96,378.9 million, respectively.

China is expected to lead the transportation services industry in the top five



emerging nations, with a value of \$677,371.5 million in 2026, followed by India and Brazil with expected values of \$173,956.8 and \$104,634.5 million, respectively.
