The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The toys & games industry within the NAFTA countries had a total market value of \$27,801.1 million in 2017. The Mexico was the fastest growing country, with a CAGR of 4.6% over the 2013-17 period.

Within the toys & games industry, the US is the leading country among the NAFTA bloc, with market revenues of \$23,457.0 million in 2017. This was followed by Mexico and Canada, with a value of \$2,275.9 and \$2,068.2 million,



respectively.

The US is expected to lead the toys & games industry in the NAFTA bloc, with a value of \$24,747.4 million in 2022, followed by Mexico and Canada with expected values of \$2,855.7 and \$2,437.7 million, respectively.
