SUMMARY

Brazil, Russian Federation, India and China (BRIC) are the emerging and fast growing countries within the transportation services industry and had a total market value of \$655,967.4 million in 2020. India was the fastest growing country with a CAGR of 4.3% over the 2016-20 period.

Within the transportation services industry, China is the leading country among the BRIC nations with market revenues of \$404,192.4 million in 2020. This was followed by India, Brazil and Russia with a value of \$129,204.6, \$96,283.1, and \$26,287.4 million, respectively.

China is expected to lead the transportation services industry in the BRIC nations with a value of \$512,519.2 million in 2025, followed by India, Brazil, Russia with expected values of \$160,651.6, \$103,718.0 and \$31,416.4 million,

respectively.
