SUMMARY

Transportation Services in Denmark industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2016-20, and forecast to 2025). The Danish transportation services industry group had total revenues of \$7.1bn in 2020, representing a compound annual growth rate (CAGR) of 0% between 2016 and 2020.

The road segment was the industry group's most lucrative in 2020, with total revenues of \$5.5bn, equivalent to 78.1% of the industry group's overall value.

The value of the Danish transportation services industry group declined by 4.8% in 2020, with the COVID-19 pandemic disrupting the supply and demand for goods, as well as their flow through transportation means.
