SUMMARY

The road segment was the industry group's most lucrative in 2020, with total revenues of \$2.9bn, equivalent to 68.4% of the industry group's overall value.

The value of the Irish transportation services industry group declined by 6.4% in 2020, with the COVID-19 pandemic disrupting the supply and demand for goods, as well as their flow through transportation means.
