SUMMARY

The South Korean transportation services industry group had total revenues of \$13.0bn in 2020, representing a compound annual growth rate (CAGR) of 0.3% between 2016 and 2020.

The marine segment was the industry group's most lucrative in 2020, with total revenues of \$7.7bn, equivalent to 59.4% of the industry group's overall value.

The value of the South Korean transportation services industry group declined by 6.4% in 2020, with the COVID-19 pandemic disrupting the supply and demand for goods, as well as their flow through transportation means.
