SUMMARY

KEY HIGHLIGHTS

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The transportation services industry within the NAFTA countries had a total market value of \$617,914.2 million in 2020.The US was the fastest growing country, with a CAGR of 4.3% over the 2016-20 period.

Within the transportation services industry, the US is the leading country among the NAFTA bloc, with market revenues of \$509,195.2 million in 2020. This was followed by Mexico and Canada, with a value of \$59,662.0 and \$49,057.0 million, respectively.

The US is expected to lead the transportation services industry in the NAFTA bloc, with a value of \$609,965.7 million in 2025, followed by Mexico and Canada



with expected values of \$69,871.8 and \$57,246.4 million, respectively.
