The top 5 emerging countries are expected to reach a value of \$864,518.8 million in 2025, with a CAGR of 4.2% over the 2020-25 period.

Within the transportation services industry, China is the leading country among the top 5 emerging nations, with market revenues of \$404,192.4 million in 2020. This was followed by India and Brazil with a value of \$129,204.6 and \$96,283.1 million, respectively.

China is expected to lead the transportation services industry in the top five



emerging nations, with a value of \$512,519.2 million in 2025, followed by India and Brazil with expected values of \$160,651.6 and \$103,718.0 million, respectively.
