The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The travel & tourism industry within the NAFTA countries had a total market value of \$1,572.2 billion in 2017. The Mexico was the fastest growing country, with a CAGR of 4.4% over the 2013-17 period.

Within the travel & tourism industry, the US is the leading country among the NAFTA bloc, with market revenues of \$1,335.5 billion in 2017. This was followed by Canada and Mexico, with a value of \$130.7 and \$106.0 billion, respectively.



The US is expected to lead the travel & tourism industry in the NAFTA bloc, with a value of \$1,608.7 billion in 2022, followed by Canada and Mexico with expected values of \$160.8 and \$140.8 billion, respectively.
