The market is categorized into three segments such as audit, tax, and advisory. Audit services include financial statement and due diligence audits. Tax services include corporate tax preparations, tax planning, and compliance with tax laws and regulations. Advisory services cover mergers and acquisitions (M&A), transaction services, valuation, risk management, sustainability consulting, and regulatory compliance.

The UK accountancy market had total revenues of \$28.6 billion in 2023, representing a compound annual growth rate (CAGR) of 5.2% between 2018 and 2023.

The advisory segment accounted for the market's largest proportion in 2023,



with total revenues of \$12.9 billion, equivalent to 45.1% of the market's overall value.

The UK accounted for a share of 12.4% of the global accountancy market in 2023.
