SUMMARY

The UK Construction industry had total revenues of \$440.0bn in 2021, representing a compound annual growth rate (CAGR) of 3.4% between 2016 and 2021.

The Non-Residential Construction segment was the industry's most lucrative in 2021, with total revenues of \$236.6bn, equivalent to 53.8% of the industry's overall value.

Decline in 2020 of 14.8% was likely due to economic disruption induced by the COVID-19 pandemic.
