SUMMARY

The fish & seafood market consists of the retail sale of ambient fish & seafood, frozen fish & seafood, fresh fish & seafood (counter), chilled raw packaged fish & seafood – processed, chilled raw packaged fish & seafood - whole cuts and dried fish & seafood. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2021 exchange rates.

The UK fish & seafood market had total revenues of \$5,506.9m in 2021, representing a compound annual growth rate (CAGR) of 3.9% between 2016 and 2021.

Market consumption volume increased with a CAGR of 1.8% between 2016 and 2021, to reach a total of 330.5 million kilograms in 2021.



The performance of the market is forecast to decelerate, with an anticipated CAGR of 3.6% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$6,560.3m by the end of 2026.
