The UK Fish & Seafood market had total revenues of \$5,426.4 million in 2022, representing a compound annual growth rate (CAGR) of 3.4% between 2017 and 2022.

Market consumption volume increased with a CAGR of 1.1% between 2017 and 2022, to reach a total of 384.3 million kilograms in 2022.

The performance of the market is forecast to accelerate, with an anticipated CAGR of 4% for the five-year period 2022 %li%2027, which is expected to drive the market to a value of \$6,596.3 million by the end of 2027.
