SUMMARY

Generics in the United Kingdom industry profile provides top-line qualitative and quantitative summary information including: market size (value 2017-21, and forecast to 2026). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

For the purposes of this profile, a generic drug is defined as a copy of an ethical (prescription) drug formerly protected by patents that have now expired. Both unbranded generics and all branded generics are included. However, off-patent drugs that continue to be offered by the original manufacturer under the original name, and which form part of the 'generic-eligible' market, are not included.

The UK generics market had total revenues of \$15.9bn in 2021, representing a compound annual growth rate (CAGR) of 6.4% between 2016 and 2021.

Market consumption volume increased with a CAGR of 1.8% between 2016 and 2021, to reach a total of 88.2 % in 2021.

Over the past five years, the UK market recorded growth of 7.4%. Growth in the market has been driven by population aging as well as government efforts to

lower the cost of healthcare.
