Summary

The UK marine freight industry had total revenues of \$29.4 billion in 2022, representing a compound annual growth rate (CAGR) of 0.3% between 2017 and 2022.

The containerized segment accounted for the industry's largest proportion in 2022, with total revenues of \$25.5 billion, equivalent to 87% of the industry's overall value.

The UK accounted for a 12.9% share of the European marine freight industry in 2022.
