The UK online retail market had total revenues of \$132,747.6m in 2021, representing a compound annual growth rate (CAGR) of 14.4% between 2017 and 2021.

Other Online Retail account for the largest proportion of sales in the UK online retail market in 2021, sales through this channel generated \$84,139.3m, equivalent to 63.4% of the market's overall value.

The UK online retail market gained traction owing to the popularity of click and collect services. With the increase in social networking, the social media market is becoming a key channel to boost online sales of retailers.
