The mortgage credit segment accounted for the largest share of the market's balances outstanding in 2021, with total balances outstanding of \$2,144.1 billion, equivalent to 91.2% of the market's overall value.

The market recorded consistent growth over 3% in the years preceding 2020, largely driven by consistently low interest rates over the period.
