The US control systems market had total revenues of \$3.6bn in 2021, representing a compound annual growth rate (CAGR) of 0.1% between 2016 and 2021.

The DCS segment was the market's most valuable in 2021, with total revenues of \$2.3bn, equivalent to 64.2% of the market's overall value.



The US is one of the largest control systems markets worldwide, accounting for 16.4% of global market revenues in 2021.
