The disposable equipment & supplies segment was the market's most lucrative in 2021, with total revenues of \$71.8 billion, equivalent to 37.9% of the market's overall value.

Demand for medical durable and non-durable goods such as ventilators, testing kits, and PPE was surging throughout 2020 amid the pandemic.
