The US Make-Up market had total revenues of \$18,209.6 million in 2022, representing a compound annual growth rate (CAGR) of 0.9% between 2017 and 2022.

Market consumption volumes declined with a CAGR of -2.4% between 2017 and



2022, to reach a total of 2,279.1 million units in 2022.

The performance of the market is forecast to accelerate, with an anticipated CAGR of 3.8% for the five-year period 2022 %li%2027, which is expected to drive the market to a value of \$21,963.2 million by the end of 2027.
